#### New Brunswick Health Research Foundation (NBHRF) www.nbhrf.com

Created in 2008, NBHRF coordinates, supports and promotes health research in New Brunswick. NBHRF has a wide array of funding opportunities for NB researchers to support the Research and Development of their health technologies. In addition to funding initiatives, NBHRF facilitates and supports the provinces health research network, one specifically focused in aging research. This network has established communication channels with multiple different stakeholders to promote and disseminate research in the province. Additionally, NBHRF provides numerous opportunities for research funding through partnerships with national agencies such as the Canadian Institute of Health Research (CIHR), AGE-WELL, and other charities and foundations. These partnerships are ongoing and changing opportunities, with more information found on their website. It also offers multiple platforms for knowledge exchange, training opportunities and networking.

NBHRF makes available the following operating grants for NB researchers:

- Establishment Grant for New Investigators

#### CABHI-NBHRF Senior's Care-Strategic Innovation Fund (Partnership Example)

 Jointly funded program to trial and evaluate innovative solutions addressing challenges in aging and brain health. This fund includes partnership with innovators (third-party vendors) to test and validate products and services. The product or service must be 'mature' for trial with the target population. The last iteration of this program was November, 2018.

As it relates to applied research, NBIF's values are to invest in research with high potential for commercialization and economic impact. Further, supporting technology development by following the Technology Readiness Level framework from the Government of Canada. In addition, NBIF offers NB researchers opportunities to learn the business and commercialization end of their products through educational webinars focused on commercialization, finding your value proposition, intellectual property, etc.

**Procurement of Goods and Services** 

### **Service New Brunswick/New Brunswick Opportunities Network** NB First Procurement Strategy<sup>1</sup> and the *Procurement Act*<sup>2</sup>

Under the New Brunswick First Procurement Policy, SNB is responsible for the procurement of goods and services for the Government of New Brunswick's departments, agencies, schools and school districts, and regional Health Authorities. Exclusive of procurement pertaining to the Department of Transportation (i.e. construction, repair, land procurements).

This policy outlines that goods and services to be procured for GNB, are procured by New Brunswicker supplies where possible. This is governed by the Procurement Act. The procurement of goods and services in relation to RHAs (i.e. Health technologies) fall under two policy items (1) Mandatory Buy-NB where Goods and services up to \$105,700 must be purchases from NB suppliers, and item (4) where NB suppliers must be invited to bid. Suppliers must be registered in the New Brunswick Opportunities Network to bid.

For the purpose of this policy, a New Brunswick supplier refers to:

- New Brunswick Manufacturer a manufacturer of goods that has a place of business in New Brunswick
- New Brunswick Vendor a vendor of goods or services that has a place of business in New Brunswick

# Horizon Health Network and Vitalité Health Network

Regional Health Authorities Act<sup>3</sup>

The Minister of Health is responsible for the provision of health care delivery in the province. As it pertains to the delivery of health care services in the province, the Minister of Health may amend the provincial health plan which includes health services to be provided, health services to be acquired (out of province), and provincial programs for the provision of health services. This includes programs for training individuals in the medical and other health professions (inclusive of practice settings), ensuring a policy framework, parameters, and standards for clinical and non-clinical services provided by Regional Health Authorities (RHA). Any amendments to the provincial health plan must follow requirements under the *Hospital Services Act*<sup>4</sup>. RHAs provide the Minister with advice regarding amendments to the provincial health plan.

The Minister of Health established provincial standards for health services in the province. Those who provide health services through an agreement with a RHA shall ensure they comply with the provincial standards laid out by the Minister. RHAs submit regional health and business plans to the Minister for approval.

- Part 3 Division C outlines the powers, duties, and responsibilities of health authorities. Provision of health needs, regional health and business plan, delivery of services.
- Part 5 General Provisions outlines compliance with provincial standards and regulations.

# New Brunswick Health Council (NBHC)

The New Brunswick Health Council (NBHC) has a dual mandate of reporting publicly on the performance of the health system and to have mechanisms that engage citizens in the improvement of health service quality. Operating under the *New Brunswick Health Council Act*<sup>6</sup> NBHC represents New Brunswick with members of the council comprising community members, policy makers, health care professionals, health care managers and academic representatives. The council's work aims to inform policy decisions regarding health care delivery in the province and is well placed to support the initiatives that result from this lab.

#### New Brunswick Association of Nursing Homes (NBANH)

The New Brunswick Association of Nursing Homes represents 68 licensed care facilities in the province and is governed by a board of directors that is representative of the seven provincial regions. In addition to working with the Department of Social Development on regulatory matters and labour groups on all matter relating to employees of nursing homes, NBANH sets out a strategic plan that highlights and supports the value of research and innovation in the nursing home setting. Specifically, the strategic plan<sup>6</sup> developed for 2017 through to 2021 promotes that NBANH is a strategic partner in facilitating research initiatives.

#### **Host Institutions**

#### University of New Brusnwick (Fredericton, Moncton, Saint John/Dalhousie), Université de Moncton, New Brunswick Community College

Post-secondary institutions produce and employ NB researchers/innovators and serve as critical actors in the development of health technologies in New Brunswick. These institutions provide many opportunities to build capacity in research trainees and professional trainees through scholarships, mentorship programs, co-operative education, etc. Most importantly, they regulate and ensure the ethical conduction of research through Research Ethics Boards (REB). Research involving human participants cannot be funded or conducted prior to ethics approval. This is a critical step in the R&D cycle for health technology development.
