

Saskatchewan Seniors Demographics


Residents 65 and older¹



Residents aged 75-84 that live alone²




Residents aged 85 and older³



 - Part of the Saskatchewan Health Authority that works with students, trainees, physicians, international medical graduates, communities, health facilities and other partners to recruit and retain physicians in Saskatchewan.

 - SHRF is the provincial funding agency that funds, supports, and promotes the impact of health research. Its strategic goals are to strengthen research capacity and competitiveness, increase investment in research and innovation, and align research with stakeholders' needs.



Provincial Priorities/New Initiatives/Announcements

The following section comprises a review of recent government announcements and budgets that have dedicated resources and action to improving programs, policy, and services offered to older adults in Saskatchewan. These priorities span both government departments highlighted above.

Assistance for seniors to live independently

- The province announced a \$250,000 one-time grant funding program called the *Facilitating Independence of Older Adults in the Community* program. It is directed to senior-serving organizations, community groups, and other interested organizations to support the development and testing of new ways of supporting seniors to maintain independence at home. At least ten organizations will receive up to \$20,000.¹⁶

Health Spending

- In Budget 2022, the province announced \$6.8 billion in health spending, which represents an increase of \$288.2 million from the previous year. The funding is allocated to the Ministry of Health, the Saskatchewan Health Authority, eHealth Saskatchewan, the Saskatchewan Cancer Agency, and 3sHealth.¹⁷

Support for Seniors

- Budget 2022 includes an increase of \$17 million on seniors supports. \$4.8 million has been earmarked for home care services, \$4.1 million for high-dose influenza vaccines for seniors, \$1.6 million for the operation of the Meadow Lake Northwest Community Lodge and \$6.5 million to hire 117 additional continuing care aides.¹⁸

Surgical and Diagnostics Waitlists

- The province announced a \$21.6 million increase to clear surgical waitlists and to fund additional surgeries in 2022-2023. The plan aims to reduce surgical wait times to pre-COVID level by March 2025.¹⁹
- \$4.9 million has been earmarked for to increase the number of CT and MRI scans and reduce wait times.

Recruitment and Retention of Health Care Workers

- The province has promised to establish an independent agency that will focus on recruiting and retaining health care workers in Saskatchewan.²⁰
- \$1.5 million was aimed in Budget 2022 to support recruitment initiatives for healthcare workers. One goal is to recruit health care workers from the Philippines, with 300 expected over the next two years.²¹
- Budget 2022 also calls for \$3.5 million to recruit and retain physicians, including family physicians in rural areas.²²
- As part of the Health Human Resources Action Plan, Saskatchewan is aiming to recruit internationally trained nurses living in Saskatchewan and Canada who may qualify for training or employment in the province. They will fund health system navigators to secure employment and/or training.²³
- The province will provide incentive packages valued at \$50,000 over three years to healthcare workers. They will also add new full-time positions, convert 150 part-time positions to full-time permanent, and offer flexible staffing approaches where possible.²⁴

Intensive Care Unit and High Acuity Beds

- The province is funding 11 additional ICU beds with \$12.5 million. There is also \$3 million for 10 additional high acuity beds.²⁵

Emergency Medical Services

- Budget 2022 calls for an investment of an additional \$10.8 million to improve emergency medical services in rural and remote areas, including ambulance services and community paramedicine.²⁶

Mental Health and Addictions

- The province is investing \$470 million to support mental health and addictions programs and services, including counselling and addiction spaces in treatment centres.²⁷

- The Ministry of Health is looking to engage with partner organizations to implement the Saskatchewan Suicide Prevention Plan and the Mental Health and Addictions Information System.²⁸

Seniors Income Plan

- The maximum payment to seniors will increase from \$30 to \$330, along with an additional \$3 million investment.²⁹

COVID-19³⁰

- The Ministry of Health Business Plan calls to ensure that PCR testing continues to be available for priority populations, outbreaks are managed in high-risk settings, and encouragement to receive vaccination and booster doses.
- High priority ventilation projects in ten long-term care homes are still being completed.

Improved Outcomes for Indigenous Clients

- The Ministry of Social Services has announced that they are actively trying to recruit more Indigenous staff into the Ministry and support Indigenous training and education. The goal is to have at least 12.6% of Ministry staff who self-identify as Indigenous and to have all middle-management of the Ministry complete Indigenous cultural training by March 31, 2023.³¹
- They are also trying to establish new partnerships with Indigenous organizations and communities to ensure effective structures and processes are implemented.
