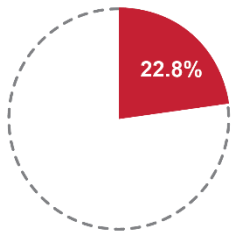

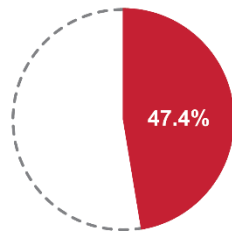

New Brunswick Seniors Demographics

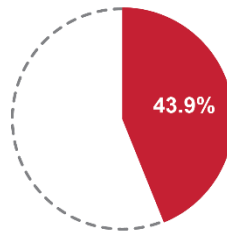
Residents 65 and older²



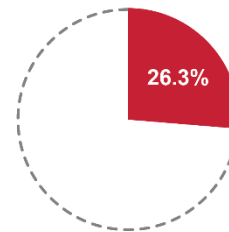
Seniors who live in rural communities³



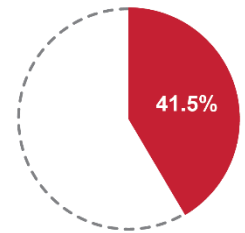
Seniors living with high blood pressure⁴

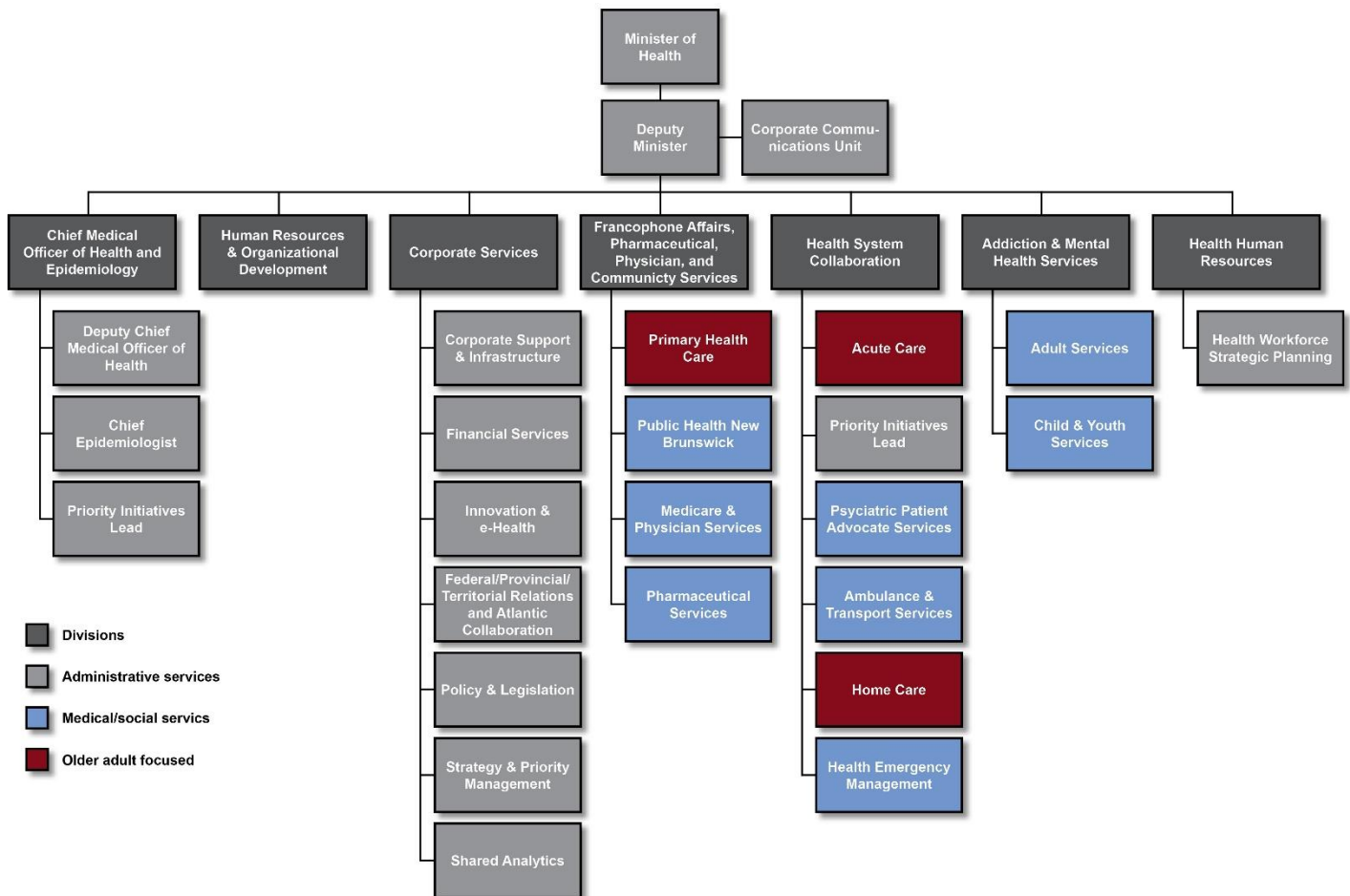

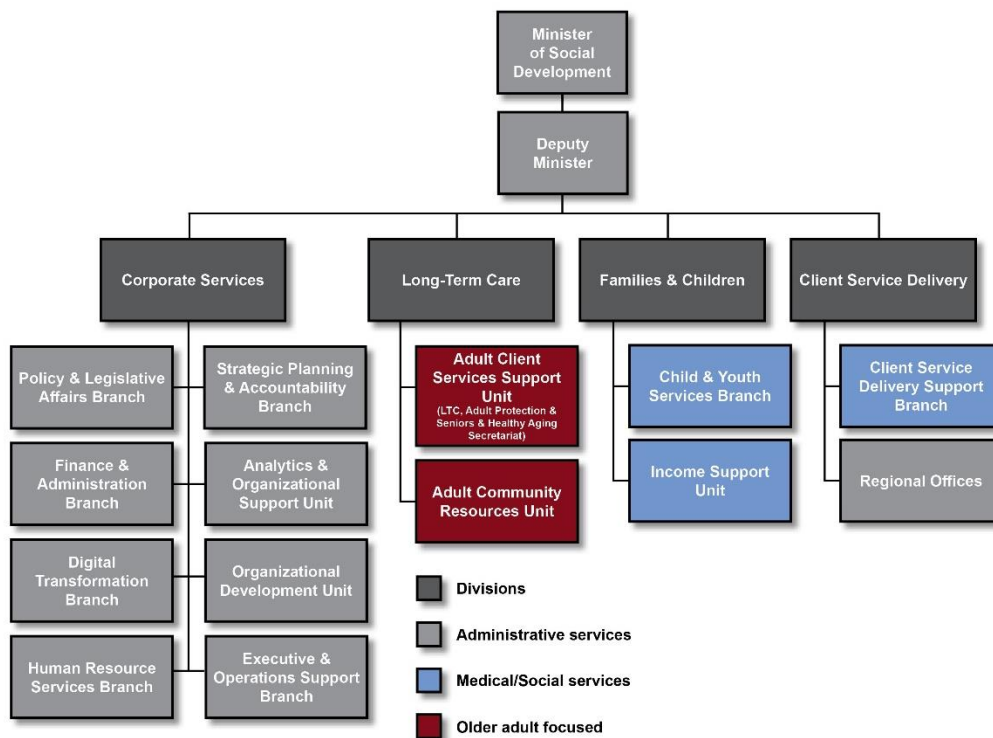

Provincial Priorities/New Initiatives/Announcements¹⁹

The following section comprises a review of recent government announcements and budgets that have dedicated resources and action to improving programs, policy, and services offered to older adults in New Brunswick. These priorities span both government departments highlighted above.

Self-Management

- Seniors' Health, Wellbeing, and Home Safety Reviews (home consultations for seniors that provide information on wellness, health, and social services; eligible seniors may also apply for \$1500 funding for small home repairs)
- Rehabilitation and Reablement Services for Seniors (intensive rehabilitation after hospital stays to return home faster)²⁰

Dependable public health care²¹

- The budget allocates nearly \$3.6 billion to the health-care system, a 10.6 per cent increase over last year's budget, and includes the increased health-care funding from the federal government.
- Additional funding of \$39.2 million will support improved access to primary health care in New Brunswick, and includes initiatives such as:
 - \$10.4 million for primary health-care transformation, including increasing the number of doctors that are working in teams.
 - \$8.5 million to address the increase in volume of services for fee-for-service physicians.
 - \$6.4 million to expand pharmacist assessment and prescribing services, and to continue to leverage eVisitNB. In this regard the province recently launched the Pharmacy Chronic Disease Pilot²² with Pharmacists at six locations across the province so to have expanded authority to assess and prescribe for some chronic conditions as well as for Group A strep (strep throat) as part of a 12-month pilot project.
 - \$3.3 million to New Brunswick Cancer Network programs.
 - \$3.2 million in operational funding for the new intensive care unit at the Dr. Everett Chalmers Regional Hospital.
 - \$2.9 million to ensure the necessary coverage for physicians working in critical services.
 - \$2.3 million to support medical residency training positions.
 - \$2.2 million to improve patient care and reduce pressures on emergency rooms and primary care providers.
- Additional health investments include:
 - \$2.1 million in funding to expand the insulin pump program and support improved diabetes management, resulting in better health for New Brunswickers²³
 - \$29.7 million to help address recruitment and retention challenges.

- \$3.1 million to consolidate hospital and laboratory information systems and improve access to diagnostic imaging data.
- \$2.4 million to expand residential treatment service in Campbellton for individuals suffering from mental health issues.
- The recently launched New Brunswick Addiction and Mental Health Helpline, a free, confidential, bilingual, 24-hour service for those looking to speak to someone about concerns related to mental health and addictions²⁴
- \$1 million to enhance addiction medicine management services.
- \$1.7 million to deliver culturally appropriate addiction and mental services for Indigenous communities.
- The Department of Health's mobile X-ray service which is being extended to long-term care residents across New Brunswick thanks to a \$1.1 million investment by the provincial government²⁵
- Expanding scope of pharmacists as they are now publicly funded to assess and prescribe for seven more illnesses and conditions²⁶

Stabilizing Health Care: An Urgent Call to Action²⁷

- In November 2022, the government released Stabilizing Health Care: An Urgent Call to Action, a plan intended to stabilize and rebuild New Brunswick's health-care system to be more citizen-focused, accessible, accountable, inclusive and service-oriented. In the 2022-2023 budget the government allocates \$38 million to move forward on the five action areas outlined in the plan:
 - Access to primary health care,
 - Access to surgery,
 - Create a connected system,
 - Access to addiction and mental health service, and
 - Support seniors to age in place.
