





Territorial Priorities/New Initiatives/Announcements

The following section comprises a review of recent government announcements and budgets that have dedicated resources and action to improving programs, policy, and services offered to older adults in Yukon. These priorities span both government departments highlighted above.

Inflation Reduction for Seniors¹¹

• The Government of Yukon announced a 10% top-up to the Yukon Pioneer Utility Grant and a one-time payment of \$150 to the Yukon Seniors Income Supplement

Housing

- In Budget 2022, the government announced \$255 million in capital investments over 5 years, of which an undisclosed amount is meant for accessible housing for seniors and people with disabilities.¹²
- The government is investing in the Normandy manor project to create 84 new homes for seniors in the territory¹³, with an increase of \$1.6 million in Budget 2023¹⁴

Community Care¹⁵

• Budget 2022 included \$86.5m for continuing care, home care, respite care, palliative care programs and community day programs.

Dental Care¹⁶

• The government is investing \$3.6m for dental care for uninsured Yukoners.

Healthcare

- Budget 2023 proposes a number of healthcare spending items:
 - \$4.4m to support the 1Health virtual care platform;
 - \$4.1m to recruit and retain healthcare staff;
 - \$3.2m to address post-public health emergency requirements;
 - \$460,000 for community nursing and nurse practitioner funding; and
 - \$279,000 to ensure a safe supply of opioids.¹⁷
- The government has also signed a Memorandum of Understanding with the Yukon Medical Association to support projects aimed at retaining healthcare workers, reduce overhead operating costs for physicians, and increase access to primary care.¹⁸
- Yukon is investing in developing a health human resources retention plan.¹⁹

Mental Health²⁰

- Yukon is spending between \$10-\$15m to create a Mental Wellness Unit at the Whitehorse General Hospital.
- \$660,000 is being invested in additional mental wellness and substance use services.

Aging in Place

 The Yukon government created the Aging in Place Action Plan in 2020, and has worked to implement its 56 recommendations, having completed 15 recommendations and started or began planning an additional 30.²¹
